

# TERMS AND CONDITIONS

## 1. Acceptance of the conditions

The website [www.srnefro.ro](http://www.srnefro.ro) is the property of the Romanian Society of Nephrology Association (hereinafter referred to as RSN), headquartered in **Bucharest, 62 Vasile Lascăr Street, 1st floor, sector 2**, with fiscal code 4681630.
